

FAQs**1. Can we submit 10th Mark sheet in place of Date of Birth Certificate?**

Reply – No, You have to submit 10th Certificate in place of Birth Certificate.

2. Is it necessary to carry original documents at NIPER JEE 2020 examination centre?

Reply – Dear applicant you have to carry only original Annexure 1 & 2 Notarized affidavit on Rs. 10/- Non-Judicial Stamp Paper in prescribed format NO NEED TO CARRY OTHER CERTIFICATE & MARKSHEETS at NIPER JEE 2020 examination centre.

3. Annexure 1 & 2 (Notarized affidavit on Rs. 10/- Non-Judicial Stamp Paper) for online counselling to be submitted at exam centre. Or to be sent online after result?

Reply – All the NIPER JEE 2020 applicant need to submit ORIGINAL notarized affidavit in prescribed format at the NIPER JEE 2020 examination centre.

4. I have filled the NIPER JEE 2020 form in EWS category but now i am facing difficulty in getting the EWS certificate so i won't be claiming myself as a EWS candidate for admission, what should I do at the time of counselling ?

Reply: - Dear Applicant, The category mentioned in your application form for NIPER JEE 2020 should be supported by required documents as per central government list. If the required documents not available, you can opt for General Category as per All India Merit.

5. In the list of documents to be submitted for counselling there is an affidavit to be submitted for anti-ragging in annexure 3 what is the registration number to be filled?

Reply:- You can fill NIPER JEE 2020 application number.

6. How i will get Notarized affidavit on Rs. 10/- Non-Judicial Stamp Paper ?

Reply – Dear applicants. You can use E-Stamping Facility: - In this manner for making use of this type of stamp the State Government has made available the facility of 'E-Stamping' throughout the State in all the Districts and Taluka Head Quarters at the office of the Sub-Registrar or authorized notary agents. By this facility as per the requirement the stamp duty payment, E-stamping certificate can be made available immediately.

Or in rare case if this facility not available you can use Notarize affidavit of Rs.10/- or above on Non-Judicial Stamp Paper.

7. I have mentioned OBC category in NIPER JEE 2020 application form but I don't have central OBC certificate and can't produce it during documents verification process since my category limited to only Maharashtra state ?

Reply :- Dear Applicant, The category mentioned in your application form for NIPER JEE 2020 should be supported by required documents as per central government list.

8. Annexure 1 & 2 (Notarized affidavit on Rs. 10/- Non-Judicial Stamp Paper) is compulsory to all.

- I. All the applicant appearing in NIPER JEE 2020 need to fill the affidavit as mentioned in Annexure – 1 as this affidavit is required to ensure the genuineness of all the documents uploaded while applying for NIPER JEE 2020.
- II. The following category applicant appearing in NIPER JEE 2020 exam need to fill the affidavit as mentioned in Annexure -2
 - a) Who have appeared in the qualifying examination but their result is not declared by the concerned university / institute.
 - b) Applicant whose final year/ semester examination have not started as of now.
 - c) Applicants who have not uploaded the marksheet of final year/ semester at the time of filling NIPER JEE 2020 online form.

Who need not to fill annexure -2 affidavit.

- **Who have already uploaded their final year/ semester exam marksheet.**

Note- Filling of Annexure -1 affidavit is mandatory for all
